Dear Stallholders

### RE: NOTIFICATION OF INCREASED STALLHOLDER FEES

I wish to thank you personally for the continued support you have given to the Riverside Markets, especially with your compliance to the COVID 19 restrictions we are experiencing. Without you there would be no markets.

This year, the Riverside Markets committee have, after much deliberation and discussion, made the decision to increase the stall fee from \$10 per stall frontage to \$15.00 per stall frontage and will no longer offer the "first stall free" option, unless the stall is run by a not for profit organization/charity.

The markets have been running for approximately 35 years under different banners ie Peel Markets, Flea Market and more recently the Riverside Markets and, for all of these years, the cost of a stall has remained at \$10.00. The decision to increase the stall fee was based on the increased running costs of the markets and the rising cost of the Lions Club of Bathurst Macquarie Inc's Riverside Markets Public Liability Insurance.

Therefore, the new fee structure will be:

- **\$15 per stall frontage (4 metres)**, with the stallholder having their own public liability insurance or,
- **\$15.00 per stall frontage (4 metres) plus \$25.00** for the use of the Riverside Markets Public Liability Insurance, **totalling \$40.00.**
